a. Telemetry.

 Another project could happen in the future for telemetry improvements at the water tower and water treatment plant. The telemetry improvements could require additional coordination with City staff or the telemetry Contractor.

8. Questions? / Comments

Gerard Tanks noted that completing painting before winter of 2022 will be critical. The representative expressed concern about the schedule and indicated that he would prefer to complete painting in October or November at the latest.

Does the tower bowl have a flat bottom or domed bottom? The specification was reviewed, and a flat or domed bottom is currently allowed.

Is there a published budget? The budget is approximately \$2.9 Million. The budget may be released.

This is a federally funded project. There are specific EDA requirements that Contractors should pay attention to when bidding the project such as the requirements for Federal prevailing wage rates.
